### **INVITATION FOR TENDERS:**

1. The Government of the United Republic of Tanzania has set aside funds for the operation of the **Korogwe Town Council** during the financial year 2018/2019. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Upgrading of roads to asphalt concrete standard Mountain View - Waarabu – Issa Mtambo road 0.85 km in Korogwe Town Council.**
2. **Korogwe Town Council** now invites sealed Tenders from eligible **National** contractors registered or capable of being registered in **Class V and above** for carrying out the **Upgrading of roads to asphalt concrete standard To Mountain View – Waarabu – Issa Mtambo road 0.85 km in Korogwe Town Council.**
3. **Tendering will be conducted through National Competitive bidding** specified in the Procurement Regulations, 2013 – Government Notice No.446 and its amendment GN 333 of 2016 and is open to all Tenderers mentioned as defined in the Regulations unless otherwise stated in the Tender Data Sheet.
4. Interested eligible Tenderers may obtain further information from and inspect the Tendering Documents at the office of the Secretary of the Tender Board at Korogwe Town Council Office from *07:30 am to 15:30 pm* on Mondays to Fridays inclusive except on public holidays.
5. A complete set of Tendering Document(s) in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 4 above and upon payment of a non-refundable fee of Tzs. 100,000.00. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to Town Director - Korogwe Town Council
6. All Tenders must be accompanied by a Tender securing declaration in the format provided in the Tendering documents unless otherwise stated in the Tender Data Sheet.

7. All Tenders in one original plus Three (3) Copies, properly filled in, and enclosed in plain envelopes must be delivered to **The Secretary Korogwe Town Council Tender Board, P. O. Box 615 – Korogwe on or before 31<sup>st</sup> January 2019 at 12:30 am.** Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening at **Korogwe Town Council min hall.**
8. Late Tenders portion of Tenders, electronic Tenders, and Tenders not received, Tenders not opened at the Tender opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
